# The opportunity

It is based in the UK but SEBP's also exist now in police forces around the world. As the SEBP Chief Operating Officer you will assist in leading that effort.

You will be the first paid member of staff for this organisation and will need to be organised, demonstrate real initiative and be passionate about improving the service the police offer through the adoption of evidence based policy.

- lead a team of volunteers at all ranks and levels, including in the private sector. You
  will focus on delivering excellent events, encourage local growth and challenge the
  team.
- develop and implement strategic partnerships with other government agencies,
   NGO's and universities to improve evidence based practice in policing
- lead the organisation's communications strategy, including branding, messaging, public relations, and digital marketing efforts to enhance visibility and engagement
- oversee fundraising initiatives, including grant writing, donor cultivation, special events, and corporate sponsorship opportunities, to secure financial support for our programs and operations
- provide leadership and direction to the team, including setting goals, managing budgets, and evaluating performance
- monitor and evaluate the effectiveness of organisational processes and systems, identifying areas for improvement and implementing solutions to enhance efficiency and effectiveness



• liaise and share good practice with other SEBP's in Australia, New Zealand, America, Netherlands, Denmark and Sweden as well as encouraging international growth.
